LOANCH EARLY-BIRD INVESTMENT BONUS TERMS AND CONDITIONS

1. GENERAL TERMS

RiseTech Kft., a company incorporated in Hungary with registration number 01-09-409513 and legal address at 1071 Budapest, Damjanich utca 58. félemelet 3. ajtó, Hungary (hereinafter referred to as "Loanch"), is providing an opportunity to earn cashback rewards by depositing and investing on the platform. By participating in this cashback campaign (hereinafter referred to as the "Campaign"), participants accept these terms and conditions (hereinafter referred to as the "Terms and Conditions") and agree to any other applicable terms and conditions that Loanch imposes.

The definitions of terms used herein are consistent with those in the platform user agreement terms and conditions (hereinafter referred to as the "General Terms"), except where the context indicates otherwise.

2. PERIOD OF THE CAMPAIGN

- 2.1. The Campaign period (hereinafter referred to as the "Campaign Period") is from **September 1, 2025, to November 11, 2025, 23:59 GMT+1** (inclusive).
- 2.2. Deposits must be made between **September 1, 2025**, and **September 30, 2025** (hereinafter referred to as the "Depositing Period").
- 2.3. Deposited funds must be fully invested in Tambadana's installment loans during the Campaign Period with at least 60 days before maturity (hereinafter referred to as the "Investing Period").
- 2.4. No withdrawal period is between **September 1, 2025**, and **October 31, 2025** (hereinafter referred to as the "No Withdrawal Period").
- 2.5. Cashback will be credited to eligible users on November 11, 2025.

3. ELIGIBILITY CRITERIA

- 3.1. The User is eligible for the cashback bonus (hereinafter referred to as the "Cashback Bonus") only if they meet all of the following criteria:
